To the Duck Club,

I hope everyone enjoyed the club opening for 2013! We hope to have a great social boating season and get to know all of our new members.

Please welcome new renter Bob Keeney who has moved into slip D57. As far as general board business goes, Doug Woods (Water) and Mike Eberhardt reported they were preparing to pole the harbor to check depth, and do any needed dredging at the end of March. Tony Longo (Land) noted he was planning to delay cleanup day this year until May to be more appropriate weather for planting.

Mike Eberhardt (Harbor Master) reported he had looked into ice bag vending machines (as an alternative to our current honor system) and found none on the market that would service this area. We are hoping that the new security system being put in place will help make our current ice system more viable. Russ Laramie (Restaurant) proposed that Social Membership dues remain the same this year (\$300), and that we continue the program to waive restaurant minimums for the first year of social membership to encourage new members. The insurance committee reported that we had secured the first quarter of club insurance.

Insurance costs came in higher than expected, so we are getting additional bids from other companies prior to the end of the quarter.

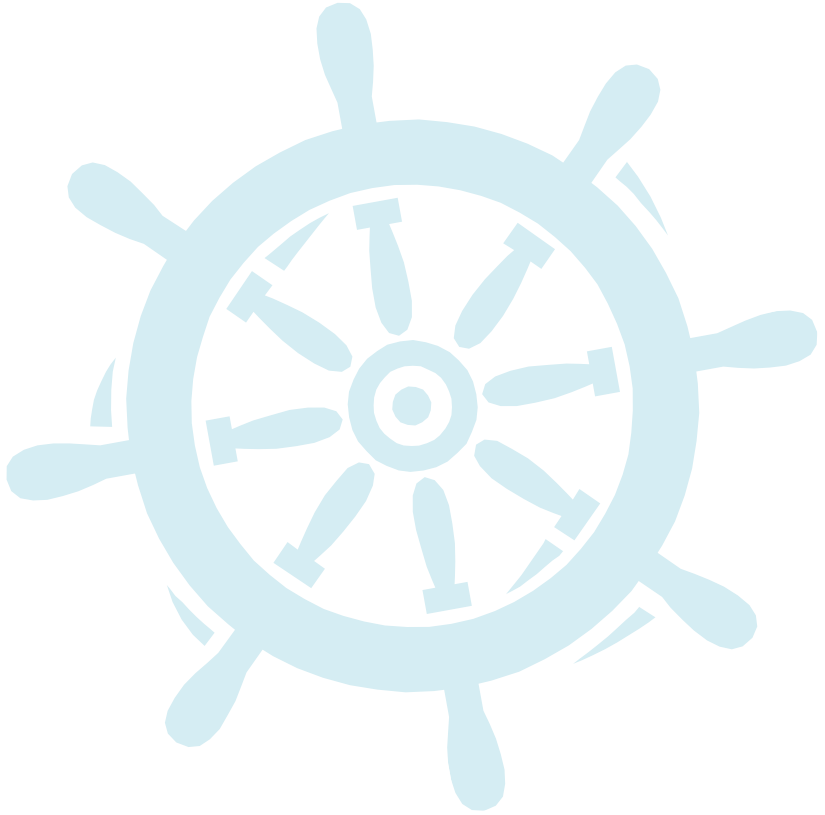
